PERFORMANCE CONDITIONS

PLEASE authorize each box with an initial and sign the bottom of the page. If there is a problem in providing any of the following conditions please contact Kevin Meier at 852-777-2927.

_____ Easy access to venue for load in, set-up, sound check, etc. a minimum of 2 hours prior to doors opening to the public. Parking must be provided with a clear path for load in/out (this point is softened due to sound equipment being provided by the DJ or facility but time will still be required for a soundcheck prior to the doors opening to the public)

_____ Load out/tear down: minimum time allotment – 1 hour

_____ There must be 2 – 110-volt receptacles on separate circuits available within 15 meters of the performance area. Please test the plugs to ensure proper operation.

_____ Seating to accommodate the audience plus a minimum of 15 chairs on stage

_____ Chairs for stage/volunteers shall NOT be able to roll nor fold and shall be free of armrests. This is non-negotiable as it is for the safety of the volunteers.

_____ Copies of the show may be made available for sale at the show. All proceeds from the sale of merchandise will be paid directly to Kevin Meier Hypnotist. All transactions will be handled by Kevin Meier Hypnotist staff. Please contact Kevin Meier Hypnotist if there are concerns regarding merchandise sales.

_____ In the event that travel back to Sangudo, AB is impractical due to distance/duration of travel 1 double occupancy non-smoking hotel room shall be provided and paid for by the event organizer in regards to the show on _____ (date) there shall be one double occupancy (i.e. 2 beds) non smoking hotel room provided by the organizer.

_____ Meals will be provided for 2 members of Kevin Meier Hypnotist before the show.

9. Travel to/from venue: if the distance to the venue is further than 100km from Sangudo, AB, there shall be a charge of \$0.52/km travel each way. This fee is due in full with the final show payment 1hour prior to the performance. I.E. Grande Cache to Sangudo= 373km x .52 = 193.96
10. Accommodations: The Purchaser agrees to provide 1 non-smoking room for the performer on the night of the event.
11. Cancellation terms: If purchaser cancels 1 within month of the performance- 25%
If purchaser cancels within 2 weeks of the performance- 50%
If purchaser cancels within 1 week of the performance- 100%

The purchaser(s) understands that Kevin Meier Hypnotist is the Hypnotist serving to provide entertainment herein. The purchaser shall pay the fee in full to Kevin Meier Hypnotist. In case of sickness, accidents, riots, strikes, epidemics or any other legitimate detention beyond the control of Kevin Meier Hypnotist that may render the performance impossible, it is understood and agreed that there shall be no claim of damages by either party to this agreement and obligation as to performance shall be waived. The tax responsibility of all net fees accepted hereunder shall be the responsibility of Kevin Meier Hypnotist unless otherwise legislated by Provincial or Federal Statute or written under special conditions of this contract. The purchaser in signing this contract themselves, or having same signed by a representative, acknowledges their authority to do so and hereby assumes liability in the amount stated herein.
